Higher Education Teaching Experience

- SFTM 5363 Advanced Equine Assisted Family Therapy (independent study, 3 credit hours)- This course will provide students with an exploration of the self of the therapist through clinical role-plays and theoretical application of MFT theories using hands-on experience working with horses. Students will learn to conduct equine sessions for a range of clinical populations and will engage in innovative equine-assisted interventions and activities through role-plays and demonstrations by faculty and equine staff. - <u>SFTM 5400 Internal Practicum (3 credit hours)</u>- This course provides students with the ability to initiate and exhibit the process of therapy as it is conducted at the Brief Therapy Institute and demonstrates competence with required documentation, conduct sessions across the course of a case including case planning and management, formulate theories of the client's presenting problem, design interventions, and explain how these relate to the student's clinical theory, by ethical standards. *Nova Southeastern University, Ft. Lauderdale, FL (Summer 2021)*
- <u>DMFT 6300 External Practicum (3 credit hours)</u>- This course provides advanced clinical training and supervision to enhance the practice of systemic therapy from strength-based, solution-oriented models of therapy that can be incorporated in a wide variety of community settings. Faculty approval is required. *Nova Southeastern University, Ft. Lauderdale, FL (Summer 2021, Fall, 2021)*
- HAWC 2006 Mindfulness and Meditation in Health (3 credit hours)- This course provides students' knowledge and skills in mindful coaching and how to use mindfulness in their practice with clients on issues that include: stress management, decision-making process, work-life balance, enhancing communication, building self-compassion, remaining present, work-life balance, and managing crises. The purpose of this course is to offer the students understanding, tools, and techniques for mindfulness practices, which includes meditative experiences to better assist them in their coaching with clients for improved health. Nova Southeastern University, Ft. Lauderdale, FL (Winter 2021, Summer 2021, Winter 2022, Summer 2022)
- DMFT/SFTD/SFTM Introduction to Equine Assisted Family Therapy (3 credit hours)—This course will provide students with an introduction to all aspects of equine-assisted mental health approaches. Beginning with an overview of the rapidly growing Animal Assisted Therapy field, the course will cover in greater depth equine-assisted psychotherapies and equine-assisted learning models, equine-assisted corporate training and team building, therapeutic riding, and hippotherapy programs. Through hands-on experience working with horses, students will be introduced to the Equine Assisted Family Therapy model being developed here at NSU. Nova Southeastern University, Ft. Lauderdale, FL (Fall 2021, Winter, 2022)
- <u>SFTD 7410 Clinical Internship (1-3 credit hours)</u> The student's immersion in the ninemonth internship experience. Students must enroll for one to three hours of internship credit each semester for nine months and until the 500 client contact hour requirement has been met. *Nova Southeastern University, Ft. Lauderdale, FL (Fall 2021, Winter 2022)*

- <u>DMFT/SFTD/SFTM Military Families (3 credit hours)</u>- This course will prepare the student to work with active military and veterans and their families. The course will cover the military culture as it interacts with the dominant culture and trace the history of cultural conflict between these different ethics. In addition, course material will be presented on PTSD and Acute Stress Disorder as they particularly apply to military situations. The stresses of deployment and reintegration on the spouses and children of military and veterans will also be discussed. The student will become prepared to work in the Department of Veterans Administration and Department of Defense settings after appropriate experience and licensure requirements are met. *Nova Southeastern University*, *Ft. Lauderdale*, *FL (Fall 2021)*
- HAWC 3019 Integrative Wellness Approaches (3 credit hours)- This course explores insights into traditional folk and non-Western approaches to health and wellness, as well as key concepts of both osteopathic and allopathic medicine.
