2021-2022[^] IP[^]: To qualify for licensure as a Marriage and Family Therapist in Florida, individuals must complete a minimum of two years of post-master's supervised clinical experience. As such, members of this cohort will not be eligible for licensure until fall 2025 at the earliest. One graduate is currently on paternity leave and plans to begin interviewing for a private practice position in September 2025.

2022 – 2023^{^^} IP[^]: To be licensed as a Marriage and Family Therapist in Florida, a minimum of two years post-master's supervised experience is required. This cohort would not be eligible for licensure until fall 2026, at the earliest.

2023 – 2024^{^^^} IP[^]: This cohort will be eligible for degree conferral in fall 2025 at the earliest. To be licensed as a Marriage and Family Therapist in Florida, a minimum of two years post-master's supervised experience is required. This cohort would not be eligible for licensure until fall 2027, at the earliest.

2024 – 2025^{^^^} IP[^]: This cohort will be eligible for degree conferral in fall 2026 at the earliest. To be licensed as a Marriage and Family Therapist in Florida, a minimum of two years post-master's supervised experience is required. This cohort would not be eligible for licensure until fall 2028, at the earliest.
